Council resolved that it would be pragmatic to take the proposals for amendment to the LPA to the AGM scheduled to be held on 23 November 2018.

Kindly diarise the date and please attend in person.


Stakeholder events are arranged to take place on Monday, 17 and Wednesday, 19 September 2018. More details will follow soon.

Friday, 13 July 2018 Meeting of the Deputy Sheriffs / Messengers of Court of Namibia

The meeting took place at Hotel Thule and was well attended by the Deputy Sheriffs and the Registrar of the High Court. From the profession, the following members attended: Graham McCullogh, Ralph Behrens, Saima Nambinga, Mathias Kashindi (GRN Attorney) and Retha Steinmann.

The discussions points were, inter alia:

- E Justice System.
- Rule 8 Service of Process.
- Removal of attached goods for auction attorneys postpone, goods to remain in storage. Defendant pays attorney and deputy is not paid.
- Sale in execution of agricultural land.
- Changes / revision of rules.
- Proposed appointment of a 2nd deputy for each district.
- Trust, business and private baking accounts. Use of trust money and auditing of trust accounts.
- Sale in execution vehicles, Natis and arrear license fees.
- The Deputy Sheriffs' obligation to follow the provisions of Rule 104 (6) (7) and (8) strictly, including, the furnishing of a nulla bona return of service and matters ancillary thereto.

The minutes of the meeting were referred to the Standing Committee on Civil Litigation for consideration.

- 1. How will GDPR affect Namibian businesses?
- 2. Has the Government been informed about GDPR and do they have a role to play in the implementation thereof?
- 3. What are the benefits of the GDPR?
- 4. Is it cumbersome and costly to implement the GDPR?
- 5. Will Namibian businesses only be affected if they do trade with EU citizens online or also in a personal interaction?
- 6. How can a business or organization protect itself against potential penalties? Must they, for example, hire a Chief Information Officer?
- 7. How can the financial sector ensure that they adhere to the regulations?
- 8. What are the impacts of GDPR in terms of the legal aspect of Namibian law?
- 9. Where does Namibia stand (status / progress) in terms of data protection?
- 10. Are there any good practices or lessons to be learnt from the GDPR that may be relevant for Namibia?

The Chevauchee Foundation invited 8 persons from the LSN to attend a lecture event on 26 July 2018 at the Protea Hotel Furstenhof, to discuss the state of the economy, the state of economic freedom in the country and garner suggestions for reform.

The event was a combination of a workshop and a lecture focusing on business, credit and labour market regulation and how these impact on economic development.

Speakers were:

- Daniel Steinmann, the founder and editor of the Namibia Economist gave "A brief history of the Namibian Capital Market, 2015 - 2018, refleting on Development Goals versus Financiang Options. What went wrong?".
 Rowland Brown, Economist addressed "Challenges faced by Namibian Entrepeneurs".
- Leonard Kamwi, the head of the Public Policy Department addressed the "Recession and the Opportunities for Reform".

The Office of the Ombudsman has been instrumental in the success of the FLAD since the project was launched in August 2014 by supporting this project and assisting the LSN with the venues and advertising in the region. Topics such as Labour, Domestic Violence, Wills & Estates, Divorce and Maintenance are addressed.

The LSN, in collaboration with the Office of the Ombudsman, hosted its 1st Free Legal Advice Day for 2018 at the Swanevelder Community Hall, Otjiwarongo where 63 persons received free legal advice.

The 2nd Free Legal Advice Day took place in Rehoboth at the Hermanus van Wyk Memorial Hall on 13 April 2018 where 121 persons received legal advice and co-incided with a Circle Meeting with the members on Thursday, 12 April 2018.

The 3rd Free Legal Advice Day took place in Ongwediva at the Office of the Ombudsman on 15 June 2018, where 53 people received free legal advice, and co-incided with a Circle meeting with the members in Oshakati on 14 June 2018.

Another FLAD and Circle meeting took place on 13 July 2018 in Gobabis where 80 persons received free legal advice.

The recent FLAD took place in Windhoek on 3 August 2018 where 25 persons received free legal advice.
