Foreword

The Law Society of Namibia stands on the shoulders of giants. Men and women, who have put their shoulders to the plough when it would've perhaps been easier to focus solely on building a practice. Women and men, who understand that the success of their unique profession requires every one of its members to participate or at least engage with the work of the LSN in some way.

The giants of today walk among us in all shapes and sizes and contribute to the success of our profession in myriad ways. Some prepare for and contribute at AGMs or other meetings related to the profession or simply make a point to attend events organised by the LSN. Others actively participate in committee work, while yet others avail themselves for Council positions. Behind the scenes are those who are always ready to listen and, if requested, offer a word of advice or handle part of a brief that wasn't actually their responsibility. On behalf of this year's LSN Council and Directorate, and myself, I express my sincerest gratitude to every one of you.

To the pioneering giants of yesterday, now on the Bench or retired or taking it easier somewhere else, and those who still practice but now focus elsewhere, your immense contributions have not been forgotten and remain highly appreciated.

2017 has been another eventful year in the profession and, even at the end of November, is not slowing down. But end it will, and when it does it will go down in my book as the most challenging yet.

The main tasks of the 2017 LSN Council have been addressing the Competition Commission's findings on the LSN's application for exemption of certain of our Rules from the provisions of the Competition Act, improving communication with members, enhancing transparency, addressing members' legitimate complaints around the management and accuracy of reporting on the LSN's finances, refining the LSN's value proposition and generally trying to introduce a more methodical approach to the activities of our organisation. Because of the tireless work of the Director, her managers and the staff of the LSN, as well as its Councillors, we've achieved our goals in some areas while others remain work in progress. I tip my hat to each and every one of you.

We hosted two successful Special General Meetings this year. The first was a lengthy and interesting affair where the members had their final say on the rule amendments necessitated by the Competition Commission's findings. The amendments to the rules have since been published and the updated rules uploaded onto the LSN's website. (I will be remiss if I do not mention that the Commission, while firm in its position, has always been willing to engage with us when necessary.) The second Special AGM was much shorter and resulted in the members approving, after several changes, two previous years' financial statements.

Our progress on the rest of the tasks have been set out in two LSN activity updates shared with members earlier this year in May and August. In the accompanying report, the detail of those earlier interim updates is repeated and extended to reflect the events of the last few months.

Personal highlights are the activity reports themselves, the appointment of our specialist Audit and Risk Committee and the slow but certain progress of the Change Project.

Low points are the passing away of several beloved members of our profession. Rest in peace Kandali Nuugwedha, Piet van Heerden, Eckart Pfeifer, Anna-marie Engelbrecht and At Slabber. (More information is available on page 11).

Another low point is the continued challenges to the sustainability of the LSN which has resulted in Council's recommendation for a marked increase in members fees on this year. One of the reasons for this increase is the double bind in which Namibia (including the organised legal profession) finds itself: we must ultimately become competitive in the global marketplace, yet at the moment don't enjoy the benefits of scale on either the supply or demand side. Our members, the public, and the LSN's other partners and stakeholders demand and deserve excellent service. The LSN and its members need highly skilled individuals to deliver these services. These individuals are in relatively short supply in Namibia and we are competing with many other organisations. These individuals therefore do not come cheap. As a self – regulating profession, members' fees are the LSN's primary income source. While larger countries can distribute the cost of regulation among a large pool of professionals and so keep individual contributions relatively low, the LSN and its members do not have this benefit. At the same time, we appreciate that increases as recommended are not sustainable as it will eventually place too large of a burden on members. We must therefore tighten our belts as far as possible. We are also aware and have heard it many a time from many a member that the limited differentiation between the levels of annual contributions, based only on post-admission experience, may not be equitable and must be changed. For these reasons the Change Project will soon make recommendations on different funding models for the LSN, hopefully to be introduced by this time next year.

Please attend the AGM of 1 December 2017 to listen to your colleagues and have your own voice heard. It promises to be a most interesting end to a most interesting year.

Council also congratulated the Director with her birthday and handed her a Certificate and Gifts to celebrate her 20 years employment at the LSN.



• Special General Meeting: 23 May 2017

The Special General Meeting, to approve the Rule changes to bring it in line with the Ruling made by the Competition Commission, took place on 23 May 2017 at the LSN boardroom.

The Special General Meeting was another milestone reached.

The Rule Amendments were approved by the Honourable Chief Justice and then submitted to the Legal Drafters. The LSN Chairperson received the Amended Rules for signature before promulgation thereof and it was published on the LSN website.

Subsequently, further correspondence was exchanged between the LSN and the NaCC.













Finances

Special General Meeting: 5 September 2017

At its meeting held on 23 June 2016, the LSN resolved to establish an Audit and Risk Committee. The appointment of the ARC was further deliberated on and in principle agreed to at the retreat of the LSN and the LPFF on 24 August 2016, attended by both organisations / consultants of both organisations.

At its meeting held on 2 November 2016, Council appointed Saima Nambinga, Gaenor Michaels and Tiaan Bazuin to serve on the ARC. At the aforementioned meeting of Council, a decision was then also made to invite applications, via the Institute of Chartered Accountants (ICAN).

The ARC had its first meeting on 26 January 2017, at which meeting Saima Nambinga was appointed as the Chairperson. At the aforementioned meeting, the ARC also considered, 3 candidates who applied for the position and appointed Debbie Smit (an auditor with relevant experience and expertise) as the fourth member of the ARC. Debbie Smit attended meetings as from the second ARC meeting.

The purpose of the Audit and Risk Committee is, *inter alia*, that it would be the first line of reporting for the Risk & Compliance Unit (RCU) at the Law Society of Namibia, to evaluate the reports of the Manager RCU and to provide the Council of the LSN with recommendations and guidance.

This committee is also tasked with certain internal auditing functions at the LSN, assisting with the LSN budget and consideration of the LSN's financial statements and investments.

After the November 2016 AGM and the comments made at the meeting, Council engaged in some introspection.

The ARC considered both the Audited Financial Statements (2014 / 2015 and 2015 / 2016), as well as the feedback received from both the auditing firms, Swart Grant Angula (SGA) and Hamilton Chartered Accountants (HCA), and subsequently made recommendations to Council. At the SGM Saima Nambinga briefly discussed some of the issues, which arose from the previous minutes of the AGM.

The AFS for both financial years were adopted at the AGM.







Stakeholder Engagement

United Nations Global Leadership Training program in Africa

On 13 January 2017, Jo-mari Koekemoer met with Hiroshige Fujii, a Japanese Scholar and a member of United Nations Global Leadership Training Program in Africa, currently based in South Africa as a visiting fellow at the University of Cape Town with funding support from the United Nations University.

• 2nd Rechtsanwaltskammer - Frankfurt am Main

During 2009, the Bar Organisation of Frankfurt am Main and the LSN agreed to a relationship of amicable cooperation between the two bodies:

- Keep mutual exchange of information about our respective legal systems, and assist to look up the law issues when necessary.
- Hold legal conferences and seminars on the mutual interests and present papers if and when appropriate.
- Reciprocal visit and training to the law firms of each organization and exchange experience.
- Recommend appropriate lawyers and firms to set up a steady relationship between the two cities to facilitate the economic development.

Unfortunately, this relationship was not used to its full fruition and a renewed effort has been made since October 2016 and a second visit to Namibia has been initiated by Frankfurt am Main Bar Organisation.

• **PSAN** - Some Councillors and the Managers at the LSN Directorate, attended a training session of the Professional Speakers Association of Namibia (PSAN) on 25 January 2017, at the Safari Court Hotel. The topics, addressed by four international speakers, included: Strategy, Marketing, Work Life Integration and Unity in Diversity and Creative New Thinking.

Professional Indemnity Insurance -The Director and Brigitte Mack (obo the LPFF) met with AON representatives, on 12 January 2017, to discuss the new requirement that the LSN or the LPFF should make a 'No Claims Declaration'. As it is not possible for either the LPFF or the LSN to have knowledge of PI claims, the practising members were requested to complete these forms and to submit it by 24 January 2017, in order to submit the information to AON by 31 January 2017.

As many of the firms were uncertain as to what was expected of them, another meeting was arranged with AON.

On 10 February 2017, AON agreed to waive the NCD, but will monitor claims on a quarterly basis. All that was requested was for the firms to confirm if any of the members / firms have expanded their business to include anything other than that of the normal duties of Attorneys / drastically downsized their staff ratio but still handle the same amount of workload. (Meaning mistakes can be made, and claims can follow.)

- A circular on how to report a potential claim was issued on 13 April 2017.
- Registrar of the High Court Jo-mari Koekemoer and Retha Steinmann met with the Chief Registrar, Elsie Schickerling on 14 February 2017, to discuss legal practitioners' availability.
- Meeting at ICAN with BIPA, MOT, BON and ICAN 6 February 2017.

- **Legal Shield** Ramon Maasdorp was invited to attend the Annual Legal Shield Bursary event, held on 16 February 2017, at Lemon Tree Opera House.
- Good Morning Namibia On 16 February 2017 and 9 March 2017 Johann du Plessis participated on NBC Good Morning Namibia discussing the Legal Year Opening and the LSN, respectively. Various other slots on GMN were attended by the Standing Committee Members.
- Climate Change On 28 February 2017, Retha Steinmann, on invitation of the French Ambassador, attended an after-hour discussion on Implementing the Paris Agreement on Climate Change, following COP21 and COP22 at the FNCC Gallery.
- Stakeholders meeting regarding Position Paper 8 March 2017. Legal Practitioners Accused of Criminal Offences / egregious offences: Towards the end of last year, we circulated to our members a Position Paper on the captioned draft Policy. The Policy is intended to clarify the approach the Council of Law Society believes it should adopt when it learns that a candidate or legal practitioner has been accused of a crime that reflects on their being fit and proper to practice as a legal practitioner, where the criminal case has not been finalised. To ensure proper ventilation of relevant issues around the Paper and proposed Policy, the LSN invited members to a dialogue at the Law Society Boardroom on Wednesday, 8 March 2017. The discussion focussed on: answering some of the questions already raised by members; clearing any misconceptions on the legal and factual foundations for the Paper and proposed policy; affording an opportunity for members to discuss with colleagues their support, reservations and / or suggestions on the draft policy: discussing and formulating possible disciplinary procedures that could strike an effective balance between the interests of the public, legal practitioners and the administration of justice (where these critical interests may clash or be seen to clash).

The meeting was attended by: Hon Minister Pohamba Shifeta, Yvonne Dausab, Amupanda Kamanja, Sylvanus Nepunda, Ramon Maasdorp, Ingrid Husselmann, Retha Steinmann and Jo-mari Koekemoer. Ramon Maasdorp and Retha Steinmann met with Wouter Rossouw (past Chairperson) to discuss the document relating to legal practitioners and candidate legal practitioners accused of egregious offences on 25 October 2017, at Longbeach Lodge. Members have again during this year been accused of criminal activities.

- **Pension** The LSN is considering 3 proposals obtained for Pension Schemes / Provident funds, to see how staff members, as well as the profession, can benefit from a group scheme. Consultative meetings will be held during May/June 2017.
- FIC & ICAN Meetings took place with the Financial Intelligence Centre of the Bank of Namibia, the Institute of Chartered Accountants and BIPA regarding matters of mutual concern.

 Task Force - On the invitation of the Honourable Chief Justice, and the leadership of the Namibian Judiciary, a team of senior members of the United States Judicial System, visited Namibia in November 2016. They consulted with stakeholders in the Namibian Criminal Justice System, with the ultimate goal of identifying sources of delay in the resolution of Criminal cases, and recommending potential solutions. Their visit culminated in their "Report and Recommendations of the U.S. Team on Criminal Justice Reform" (the Report).

On 29 March 2017, on the invitation of the Chief Justice, several key stakeholders in the Criminal Justice system, including the LSN who was represented by Ramon Maasdorp and Ingrid Husselmann, attended a consultative session on the Report.

The Task Force is led by the Deputy Chief Justice and will ultimately report to the Chief Justice. The Chief Justice will make Policy decisions and consult whom ever needs to be consulted for decisions outside of the Task Force members' scope of authority.

The Task Force meeting took place on Thursday, 27 April 2017. Ramon Maasdorp was appointed to the Task Force and has attended subsequent meetings.

- Namlex Chambers The Director was elected as Trustee, representing the LSN on the Namlex Body Corporate, at the BC's AGM held on 2 March 2017.
- Wildlife Protection Jo-mari Koekemoer and Daan Small attended the Workshop on Wildlife Protection and fundraising event on 3 March 2017, at the Safari Hotel.
- Public Lecture Members were invited to a public lecture by a visiting US District Judge, Victoria Roberts, on "The Checks and Balances of the US Government" at the Mining Auditorium at NUST. She was visiting Namibia on invitation of the Namibian Judiciary. The public lecture was co-branded by the LSN and the US Embassy. Ramon Maasdorp introduced the speaker.

 Disciplinary Committee - The LSN appointed Ingrid Husselmann, Silvanus Nepunda, Charmaine van der Westhuizen and Ruth Herunga as members of the independent statutory Disciplinary Committee. Subsequently, Charmaine van der Westhuizen was elected as Chairperson. The Hon. Minister of Justice appointed Amber Coerecius as the Secretary of the Disciplinary Committee. The DC met regularly during the year.

 Disciplinary Committee - The Director met with Gladice Pickering – Deputy Permanent Secretary of the Ministry of Justice, on 17 May 2017 to discuss, inter

alia, the functioning of the Disciplinary Committee.

• DC and Legal Ethics - The LSN Chairperson met with the members of the Disciplinary Committee and the Legal Ethics and Investigatory Committee on 7 March 2017. The discussion points, inter alia, were: Setting and documenting a consistent standard throughout the disciplinary process, from complaint intake to high court applications; Increasing transparency in the disciplinary process, including ensuring complainants have access to LP responses and reasons for all decisions; Securing/optimizing resources to assist with DC investigations, prosecutions and administrative functions for both committees, e.g. securing a committed pool of practitioners and arranging training and possibly funding. Members are requested to assist the DC should it be required. On Wednesday, 13 September 2017, the Deputy Permanent Secretary updated the Director and Ms. Koekemoer on the challenges experienced by the DC, as well as the positive

development that a dedicated office is now occupied by the Secretary to the DC.
 Press Statements - The LSN issued a statement in support of the SADC LA and the Law Association of Zambia in response to the siege of the LAZ offices on 3 March 2016 and the Zimbabwean situation in November 2017.

 Namibian Law Reports – Funding was required by the LAC to pay the editor of the law reports. The LSN called upon its members who are willing to contribute towards the funding of the Namibian Law Reports to contact the LAC. Request for funding have also been made to the LPFF, the NLPT and the Society of Advocates. An amount of N\$140,000.00 is required per year. Namlex - A meeting took place on Wednesday, 13 September 2017 between Gladice Pickering, Deputy Permanent Secretary of the Ministry of Justice, Anel van der Vyver, of the Office of the Attorney General, the Director and Manager Professional Affairs.

The Office of the Attorney-General and Ministry of Justice, in collaboration with the Legal Assistance Centre, are undertaking a short term project to update Namlex. In preparation for this project they have come to the realization that there are several local websites, which provide online access to Government Gazettes and annotated statutes with varying degrees of accuracy. Even the paid for South African databases are not without errors.

The long term vision is to provide a local database hosted on a few existing platforms which provides online access to legislation in Gazette and annotated form, bilateral and multilateral treaties and court cases relevant to the legislation. In order for this to materialize the buy in of the private sector through the Law Society of Namibia was required.

- Social Media and Disruptive Technology Conference: Jo-mari Koekemoer attended the conference on 11 April and Ramon Maasdorp attended on 12 April 2017.
- China-Africa Young Legal Professionals Exchange Program: Members were invited to indicate interest to be nominated for consideration to attend the sponsored 4th Course of China-Africa Young Legal Professionals Exchange Program. Subsequently, the LSN was advised that Lydia has been selected for participation in 2017.
- China Law Society At its meeting held on 23 October 2017, Council resolved that Katja Klein and Vincia Cloete shall be tasked with setting out a framework for complying with the request of the China Law Society for the establishment of expert committees to fulfill the Johannesburg Action Plan (2016 2018) adopted at the FOCAC Johannesburg Summit during December 2015.
- NAMBIZONE The Director attend the launch of the Integrated Client Service Facility Portal the one-stop Shop NAMBIZONE, on 18 May 2017, at the Safari Hotel.
- 241st Anniversary of the Independence of the United States of America The Director attended the reception held on Monday, 3 July 2017, at the Safari Court Hotel.

meeting with the Registrar of the High Court and the Crimson Logic team to discuss the
feedback from the members regarding problems experienced with e-Filing on 31 August 2017.
Members were therefore requested to urgently submit their submissions in order for the

Chairperson and the Director to address concerns.

Consultative meeting of the Namibia Intelligence Service - The LSN could only be presented by 2 practitioners to attend the meeting. The Chairperson and Vice-Chairperson







FREE LEGAL ADVICE DAYS (FLAD)

The Free Legal Advice Day forms part of the Law Society's objectives to make legal services more accessible to those members of the public who cannot afford legal services. The Office of the Ombudsman has been instrumental in the success of the FLAD since the project was launched in August 2014 by supporting this project and assisting the LSN with the venues and advertising in the region.

During 2014, two Free Legal Advice Days took place in Oshakati / Ongwediva and Keetmanshoop.

During 2015, four Free Legal Advice Days took place in Tsumeb, Windhoek, Swakopmund and Gobabis.

During 2016, only one Free Legal Advice Day took place in Windhoek, due to the LSN Directorate being short staffed.

The Law Society of Namibia, in collaboration with the Office of the Ombudsman, hosted various Free Legal Advice Days during 2017 where topics such as, Labour, Domestic Violence, Wills & Estates and Divorce and Maintenance were addressed.

• Financial Intelligence Centre

The Financial Intelligence Centre (FIA), conducted a training session on the 14 and 21 July 2017 on the elements of the Financial Intelligence Act (2012) for reporting institutions. The training focused on the correct interpretation and implementation of the provisions of the Act. This session was arranged on behalf of the LSN by the Manager Professional Affairs.

The training was beneficial to the legal fraternity. It was noted that the Act under Section 39 (8) states that:

An accountable institution must develop audit functions to evaluate any policies, procedures and controls developed under this section to test compliance with the measures taken by the accountable institution to comply with this Act and the effectiveness of those measures.

The section requires law firm to have an independent audit conducted to express an opinion on the firm 'compliance with the FIA requirements. Legal practitioners present at the training requested the LSN to assist firms in conducting FIA compliance audits and providing advisory function in this area.

The RCU had previously communicated to the Institute of Chartered Accountants (ICAN) on the need to incorporate FIA compliance audits as part of the trust inspections. However, the LSN was cautioned that this would increase audit fees for law firms as it would increase the time spent on the audits.

The RCU has incorporated FIA inspections in it's the annual programme as from January 2017. Firms currently using external auditor would have to negotiate with the external auditors to include FIA audits in the annual scope. Law firms will be engaged by the RCU on the costs aspects in due course.






• CPD - Drafting
